## SURVEY METHOD

This survey was conducted online within the United States from **Field Dates: October 26-28, 2021** among **1,578 registered voters** by The Harris Poll.

Results were weighted for age within gender, region, race/ethnicity, marital status, household size, income, employment, education, political party, and political ideology where necessary to align them with their actual proportions in the population. Propensity score weighting was also used to adjust for respondents' propensity to be online.






### US Economy: Right Track / Wrong Track



M2. In general, do you think the American economy is on the right track or is it off on the wrong track?



## How strong do you think the U.S. economy is today?

































































































































































**Do you think the number of monthly border crossings by illegal immigrants has increased, decreased, or stayed the same since President Biden took office?**




















Would you accept payment from your employer in cryptocurrency?














