SURVEY METHOD

This survey was conducted online within the United States from September 7-8, 2022 among 1,885 registered voters by The Harris Poll and HarrisX.

Results were weighted for age within gender, region, race/ethnicity, marital status, household size, income, employment, education, political party, and political ideology where necessary to align them with their actual proportions in the population. Propensity score weighting was also used to adjust for respondents' propensity to be online.







U.S. Economy: Right Track / Wrong Track





How strong do you think the U.S. economy is today?





Would you say that your personal financial situation is improving or getting worse?



In general, are you feeling optimistic or pessimistic about your life over the next year?





President Biden Overall Approval










DEMOCRATIC PARTY APPROVAL HAS CLOSED THE GAP, NOW AT 47%
















If former President Donald Trump does not run for president in 2024, who would you vote for in the GOP primary? (GOP voters)



If the Democratic presidential primary for the 2024 election was held today, who would you vote for? (DEM voters)




If President Biden decides not to run again in 2024, who would you prefer to be the Democratic candidate? (DEM voters)




If the 2024 election for president were held today and it was between Donald Trump, the Republican and Joe Biden, the Democrat, who would you vote for?








Why should Donald Trump not run for president in 2024? [Among those who say he should not run]













































































Do you think President Biden gave a presidential policy speech in Philadelphia or did he give a partisan political speech?




Given this was it appropriate or inappropriate for him to give the speech in a federal building?



Given this was it appropriate or inappropriate for the president to have marines standing behind him during his speech?







Do you favor or oppose the addition of 87,000 new IRS agents?




A LARGE MAJORITY OF VOTERS WOULD PREFER A GASOLINE-POWERED VEHICLE OVER AN ELECTRIC ONE

Over the next 15 years, should consumers be banned from buying gasoline-powered cars or should consumers have a choice of buying electric or gasoline-powered cars?





In general, would you prefer to drive an electric car or a gasoline-powered car?





Do you think the electric grid is ready for the widespread purchase of electric cars or is the electric grid not ready?











How much have you heard about the Biden administration reducing student loan debt by \$10,000 for close to 30 million Americans, if anything?





Are you personally helped by this executive order, hurt by it or not affected by it?




Do you think it was right or wrong for President Biden to spend over \$500 billion on student loan forgiveness without authorization by Congress?





Do you think his act will be held as a lawful exercise of presidential authority or will it be held as unconstitutional in violation of Congress' power of the purse?








Do you think that the debt relief will help reduce the cost of college or will colleges just raise their tuition and capture most of the government money?
