SURVEY METHOD

This survey was conducted online within the United States from January 18-19, 2023 among **2,050** registered voters by The Harris Poll and HarrisX.

Results were weighted for age within gender, region, race/ethnicity, marital status, household size, income, employment, education, political party, and political ideology where necessary to align them with their actual proportions in the population. Propensity score weighting was also used to adjust for respondents' propensity to be online.










LESS THAN FOUR IN TEN SAY THE U.S. ECONOMY IS STRONG

How strong do you think the U.S. economy is today?






Do you think the U.S. is in a recession now, will be in a recession in the next year or most likely will avoid a recession?








Do you approve or disapprove of the way Congress is doing its job?












If former President Donald Trump does not run for president in 2024, who would you vote for in the GOP primary? (GOP voters)



If the Republican party primary is down to two choices, Ron DeSantis and Donald Trump, who would you choose to run as president in 2024 among the two? (GOP Voters)





If the Democratic presidential primary for the 2024 election was held today, who would you vote for? (DEM voters)




If President Biden decides not to run again in 2024, who would you prefer to be the Democratic candidate? (DEM voters)














MOST SAY THE BIDEN SHOULD NOT RUN FOR A SECOND TERM

Do you think President Biden should run for a second term or not run for a second term?








































Do you think that Hunter Biden paid his taxes and filed his representation of foreign governments or do you think he did not comply with these laws?










MOST VOTERS UNDERESTIMATE THE SIZE OF THE NATIONAL DEBT

What do you think is the size of the federal budget?

































For each of the following industries, do you think we need more regulation, less regulation or about the same level as we have now




MOST VOTERS OPPOSE THE PROPOSED BAN ON GAS STOVES
