SURVEY METHOD

This survey was conducted online within the United States from March 22-23, 2023, among **2,905 registered voters** by The Harris Poll and HarrisX.

Results were weighted for age within gender, region, race/ethnicity, marital status, household size, income, employment, education, political party, and political ideology where necessary to align them with their actual proportions in the population. Propensity score weighting was also used to adjust for respondents' propensity to be online.









How strong do you think the U.S. economy is today?







In general, are you feeling optimistic or pessimistic about your life over the next year?









Do you approve or disapprove of the way Congress is doing its job?









Is Joe Biden mentally fit to serve as President of the United States or do you have doubts about his fitness for office? (Split sample)












Do you think Donald Trump will win or lose the Republican primary for president?



























If Donald Trump was the Republican nominee and Joe Biden the Democratic nominee, would you support or not support an independent moderate candidate running for the presidency in 2024?







Have you heard or not heard anything about democratic Manhattan district attorney Alvin Bragg wanting to indict former President Trump?














Do you think that such a trial of former President Trump will help or harm his 2024 candidacy for president?





How much have you seen, read, or heard about collapse of Silicon Valley Bank and Signature Bank the last two weeks?




Do you think the failure of these banks will impact you personally or not?








Are you worried or not worried that there will be a 2008-style banking crisis this year?







Were you aware that Silicon Valley Bank's clients included a lot of technology startup companies?




Do you think the collapse of Silicon Valley Bank will ultimately help or hurt America's tech sector and technology competitive or will it not matter?



Do you agree or disagree with the Biden administration's decision to step in and guarantee all customer's deposits from these banks?




Do you agree or disagree with the Biden's administration's decision not to inject capital into these banks and therefore not protect its shareholders?








Should the government fully insure deposits at all U.S. banks, or only at systemically important firms?
















What, to the best of your knowledge, is the year-over-year U.S. inflation rate?



Do you think the Federal Reserve raising interest rates aggressively led to the current bank failures or are these failures mostly the result of poor risk management by these banks?













Is China an ascending global power that seeks to replace the United States as the key player in global affairs or does it not seek to do that?







Does China's foreign policy help or hurt peace and stability around the world?





Does China's foreign policy help or hurt the development of a rules based international system around the world?




What is the likelihood China will invade Taiwan in the next 5 years?










Is the Biden administration doing too much, too little, or about the right amount to counter Russia's influence and its war in Ukraine?



Do you support or oppose the United States government supporting Ukraine until Russia pulls all invading forces from its territory or is defeated on the battlefield?








MOST VOTERS THINK CHINESE STEAL DATA FROM U.S. CONSUMERS, GOVERNMENT

Do you think Chinese companies protect or steal data from U.S. consumers and the U.S. government?








Do you have confidence or not have confidence in politicians' ability to understand AI technology and regulate if needed?




Do you think companies like OpenAI should be required to provide their data/training sets to the public?




A VAST MAJORITY OF VOTERS THINK COMPANIES SHOULD BE REQUIRED TO LABEL AIGENERATED OUTPUT









Do you think the U.S. Government is doing enough too much, too little or just enough to regulate the transportation and disposal of toxic chemicals?





Who do you think is most to blame for the train derailment in East Palestine, Ohio?











Have you heard of the medications Mifepristone or Misoprostol?




Based on what you know, do you think these medication are legal or illegal in your state?



Based on what you know, do you think emergency contraceptives, sometimes called the morning after pill or Plan B, are legal or illegal in your state?








MOST VOTERS SUPPORT WALGREEN'S REFUSAL TO DISPENSE EMERGENCY CONTRACEPTION




WOMEN PAY GAP

Do you believe there is a gender pay gap in America, or more simply put, do you believe women are typically paid less than men on average?










